Purpose:

- Better understand the Governor's 2018-19 budget proposal regarding community alternatives to reduce the number of Incompetent to Stand Trial (IST) referrals to DSH
- Better understand the current situation related to the increasing number of IST referrals to DSH

Background:

The Governor's Proposed 2018-19 State Budget includes funds to support state-local partnerships to reduce the growing number of individuals who are being referred to the Department of State Hospitals (DSH) for competency restoration. The programs funded will focus on diverting individuals with mental illness who are at risk of being referred to DSH as an IST. As such these funds aim to provide intensive community-based alternatives. To aid in this dialogue we will have presentations from DSH and the Progress Foundation among others.
